

L-AVVIŽ DWAR IL-PRIVATEZZA
APPLIKAZZJONI GHAL APPUNTAMENT BIEX ISSIR IL-KARTA TAL-IDENTITÀ D-DAR

Bis-sottomissjoni tal-formola ID6A – Applikazzjoni għal Appuntament biex issir il-Karta tal-Identità Maltija flimkien ma' dokumenti neċċesarji oħra annessi magħha, inti qed tiprovd iż-żgħid li l-identità b'informazzjoni personali, u għalhekk issir suġġett għad-data.

L-ġhan ta' dan l-avviż dwar il-privatezza, huwa sabiex inkunu konformi mal-obbligi ġusti u trasparenti taħt ir-regolamenti generali dwar il-protezzjoni tad-data, u biex ninfurmaww dwar min se jkun qed jipproċessa l-informazzjoni tiegħek, għal liema għan, għal kemm żmien se tinżamm, ma' min se tkun qed tiġi kondiviża/titqassam u dwar id-drittijiet tiegħek bhala suġġett għad-data taħt ir-regolamenti generali dwar il-protezzjoni tad-data.

Inti tista' tissottommetti informazzjoni personali ta' individwi oħra permezz ta' din il-Formola (eż. rakkmandant, xhud eċċ). Identitā tabbilit li, f'tali ċirkostanzi, ikun imposibbli li tinforma lil dawn l-individwi u tali eż-żerċċju jirrikjedi sforzi kbar. Identitā se tapplika miżuri adegwati sabiex tipproteġi d-drittijiet, il-libertajiet u l-interessi leġġittimi ta' dawn l-individwi.

01 Uffiċċjal għall-Kontroll tad-Data u Protezzjoni tad-Data

Identitā hija l-kontrollur tad-data, li jfisser li hija l-entità li tistabbilixxi l-għanijiet u l-meżzi li bihom tiġbor u tiproċċessa l-informazzjoni tiegħek b'rabta ma' din il-formola.

Identitā hija aġenċija tal-Gvern ta' Malta li toffri servizzi b'rabta ma' Karti tal-Identità, Passaporti, Visi, Espatrijati u Reġistru Pubbliku.

L-Uffiċċjal tal-Protezzjoni tad-Data ta' Identitā huwa responsabbi li jindirizza kwalunkwe mistoqsja b'rabta ma' dawn ir-regolamenti u b'mod in generali dwar attivitajiet ta' proċessar ta' data li jsir minn Identitā. L-Uffiċċjal tal-Protezzjoni tad-Data ta' Identitā jista' jkun ikkuntattjat f'dan l-indirizz:

02 Għanijiet u baži legali

L-ġhan wara l-ġabrab ta' informazzjoni personali permezz ta' din l-Applikazzjoni huwa sabiex jiġi ssettjat appuntament għal žjara d-dar biex issir il-Karta tal-Identità. L-informazzjoni provduta l-Applikazzjoni tiġi mbagħad popolata fis-sistemi tal-istess Aġenċija.

Il-bażi legali għall-iproċċessar tad-Data hija t-twettiq ta' kompitu fl-interess pubbliku minn Identitā u b'mod konformi mal-obbligi legali li joħorġu mill-Att dwar il-Karta tal-Identità u Dokumenti oħra tal-Identità, Kapitlu 258 tal-Ligijiet ta' Malta.

Aħna kburin li nżommu d-data tiegħek sigura u se nieħdu l-miżuri tekniċi u organizzattivi sabiex inħarsu d-data tiegħek kontra pprocessar mhux awtorizzat jew illegali, inkluz kontra telf, qerda, hażna jew aċċess aċċidental. Id-data personali tiegħek tinżamm f'fajls tal-karti u/jew b'mod elettroniku fuq is-sistemi tat-teknoloġija tagħna.

03 Min se jaċċessa l-informazzjoni personali

L-impiegati ta' Identitā se jkollhom aċċess għall-informazzjoni personali tiegħek sabiex jipproċessaw din il-formola. Din l-informazzjoni tista' tkun trasferita lil dipartimenti fi ħdan Identitā sabiex tiffaċilita t-twettiq tas-servizz mitlub permezz tas-sottomissjoni ta' din il-formola.

L-informazzjoni se tkun trasferita wkoll lill-Kummissjoni Elettorali ta' Malta, u jekk ikun il-każ, tista' tiġi aċċessata wkoll minn forniturei ta' Identitā li jieħdu ħsieb il-manutenzjoni tad-databases tal-Aġenċija.

Dan se jsir fuq il-linji gwida tal-Liġi tal-Protezzjoni tad-Data, filwaqt li hemm bosta arranġamenti sabiex jiggarrantixxu s-sigurtà ta' dawn it-trasferimenti, u biex kolloks isir skont il-liġi.

Taħt ċerti kundizzjonijiet, Identitā tista' tiżvela l-informazzjoni tiegħek ma' partijiet terzi, (bħal entitajiet Governattivi oħra u awtoritajiet għall-infurzar tal-liġi) jekk ikun neċċesarju, u għal għanijiet spċċifici u legali.

L-informazzjoni ma tigħix trasferita lejn pajjiżi terzi jew organizzazzjonijiet internazzjonali.

04 Perjodu ta' żamma

L-informazzjoni provduta tinżamm għal erbgħin (40) sena mis-sottomissjoni ta' din l-applikazzjoni.

05 Id-drittijiet tiegħek

Tista' tagħmel kuntatt mal-Uffiċċjal tal-Protezzjoni tad-Data sabiex też-żerċita d-dritt tiegħek għal aċċess, tirratifika jew jekk jingħala l-bżonn, thassar id-Data, b'konformità mal-liġijiet li jaġġikkaw. Għandek ukoll id-dritt li toġġeżżjona għall-iproċċessar tad-data fi kwalunkwe żmien, abbażi ta' sitwazzjonijiet partikolari.

Jekk thoss li l-Aġenċija Identitā kissret xi drittijiet dwar il-protezzjoni tad-data tiegħek tista' tissottommetti l-ilment tiegħek lill-awtorità responsabbi fl-Istat Membru fejn inti tgħix, jew fejn inti taħdem, jew lill-awtorità responsabbi fl-Istat Membru fejn allegatament inkissru dawn id-drittijiet.

APPOINTMENT FOR AN IDENTITY CARD HOUSE VISIT APPLICATION

By submitting this Appointment for an Identity Card House Visit Application ("Application") together with the necessary documents annexed to it, you provide Identitá with personal data (the "Data") and thus become a "data subject". The aim of this policy is to comply with our transparency and fairness obligations under GDPR and to inform you about who will be processing your Data, for what purpose, for how long it will be kept, with whom it will be shared and about your rights as a data subject under the general data protection regulations. You may submit personal data of individuals other than yourself with this Application. Identitá will still take appropriate measures to protect the rights, freedoms and legitimate interests of these individuals.

01 Data Controller and Data Protection Officer

Identitá is the data controller, meaning the entity that defines the purposes and means for collecting and processing your Data in relation to this Form.

Identitá is an Agency of the Government of Malta, delivering services related to Identity Cards, Passports, Visas, Expatriates and Public Registry.

Identitá's Data Protection Officer is responsible to attend any query related to this policy and in general to personal data processing activities conducted by Identitá. The Data Protection Officer may be contacted using the details below.

02 Purposes and legal basis

The purpose for processing personal data collected within this Application is that of setting up an appointment for a house visit to apply for an identity card. The data provided in the Application is then populated in the databases of the said Agency.

The legal basis for processing the Data is the performance of a task carried out in the public interest by Identitá Agency and compliance with the legal obligation in accordance with the Identity Card and Other Identity Documents Act, Chapter 258 of the Laws of Malta.

We take pride in keeping your data secure and will take appropriate technical and organizational measures to protect your data against unauthorized or unlawful processing, including against accidental loss, destruction, storage or access. Your personal data will be stored in paper files and/or electronically on our technology systems.

03 Recipients of personal data

Data will be accessed by Identitá employees in charge of processing the Application.

It may also be transferred to other departments within Identitá in order to facilitate the delivery of the service requested by submitting this Application. Data will also be transferred to the National Statistics Office.

This will be done in line with data protection legislation, and arrangements are in place in order to guarantee the security and lawfulness of these transfers.

Under certain conditions, Identitá may disclose your information to other third parties, (such as other Government entities or law enforcement authorities) if it is necessary and proportionate for lawful, specific purposes.

Data will not be transferred to third countries or international organizations.

04 Storage period

Data will be stored for five (5) years after the date of death of the individual concerned.

05 Your rights

You can contact the Data Protection Officer in order to exercise your right to access, rectify and, as the case may be, erase the Data, in compliance with applicable laws. You also have the right to object to the processing of Data at any time, on grounds relating to your particular situation.

If you feel that Identitá has infringed your data protection rights, you may submit a complaint to the supervisory authority of the Member State of your habitual residence or place of work, or, alternatively, to the supervisory authority of the Member State where the alleged infringement has taken place.
