#### SUPPORTING DOCUMENTS

Applications must be submitted by email to noneu.identita@gov.mt or eu.identita@gov.mt, depending on the applicant's nationality. Applicants are required to fill in the relevant forms which must include all the required information, contact details, dates and signatures. This must be done before the expiry of the authorisation to stay in Malta.

The original version of all documents submitted with this application must be presented at the time of the biometrics appointment.

#### Spouse of a Maltese (by virtue of Article 4(1)(g) of Chapter 217):

- Full copy of the applicant's valid passport including the blank pages (EU applicants Bio page only);
- A copy of the bio page of the Maltese national's passport;
- Copy of the Maltese national's ID card;
- A copy of the spouse's residence permit if applicable;
- A copy of the Divorce Certificate if the spouse had a previous marriage;
- Birth certificate of the spouse apostilled if not issued in an EU country;
- A copy of the Marriage Certificate (registered in Malta).

#### Child of a Maltese Citizen under the age of 21 (by virtue of Article 4(1)(f) of Chapter 217)

- A copy of the birth certificate;
- Proof of custody<sup>\*</sup>.

#### Children of the applicant under the age of 21 (where the applicant is married to a Maltese national) (by virtue of Article 4(1)(f) of Chapter 217)

- Full copy of the applicant's valid passport including the blank pages (EU applicant's Bio page only);
- A copy of the bio page of the Maltese national's passport;
- A copy of the Maltese national's ID card;
- A copy of the foreign parent and child's residence permit/document if applicable;
- A copy of the Birth Certificate of the child including apostilled in case it is not issued from an EU country;
- Proof of Custody<sup>\*</sup>;
- A copy of the Marriage Certificate (registered in Malta between the childs parent and the Maltese sponsor).

#### Widow of a Maltese Citizen (by virtue of Article 4(1)(h) of Chapter 217):

- A copy of the Marriage Certificate registered in Malta;
- A copy of Death Certificate of the Maltese citizen;
  - Sufficient legalised or official documentary evidence that proves without a doubt that the exempt status holder was living together with the Maltese national at the time of death.

\* Proof of full care and custody is required where the sponsor has sole custody. Where the custody is shared, the agreement of the other parent is required.

#### NOTES TO APPLICANTS

- **01** The right to apply for a residence document reflecting the person's right to exempt person status is without prejudice to any rights such person may enjoy under European law.
- **02** All required documents together with photocopies thereof should be enclosed with an application. English translation of documents is required, if applicable. All photocopies are to be provided by the applicant.
- **03** Applications in respect of minors, that is, persons who are still under 18 years of age, are to be submitted and signed by the parent/s or a person who has guardianship of the child.
- **04** Persons concerned are being reminded that, without prejudice to any legal action that may be taken against them if false information is deliberately given, this would lead to the rejection of the application.
- **05** Prior to submitting an application it is to be emphasized that the applicant should have obtained the letter of confirmation from Identità regarding the right to hold an exempt person status.
