Privacy Policy - Power of Attorney

By submitting the Power of Attorney ("POA") and any necessary attachment(s) (altogether the "POA"), you provide Identità with personal data (the "Data") and thus become a "data subject".

The aim of this policy is to comply with our transparency and fairness obligations under GDPR and to inform you about who will be processing your Data, for what purpose, for how long it will be kept, with whom it will be shared and about your rights as a data subject under GDPR.

You may submit personal data of individuals other than yourself with this POA. Identità has assessed that, in said cases, informing these individuals proves impossible and would involve a disproportionate effort. Identità will still take appropriate measures to protect the rights, freedoms and legitimate interests of these individuals.

01 Data Controller and Data Protection Officer

Identità is the data controller, meaning the entity that defines the purposes and means for collecting and processing your Data in relation to this POA. Identità is an Agency of the Government of Malta, delivering services related to Identity Cards, Passports, Visas, Expatriates and Public Registry. Identità's Data Protection Officer is responsible to attend any query related to this policy and in general to personal data processing activities conducted by Identità. 02 Purposes and legal basis

The purpose for processing Personal Data by Identità is to receive, assess and process a request for issuing a new residence card for a third-country national. Personal Data collected in this POA will be used to populate Identità's information system, where the Personal Data will be kept in a highly secure manner.

Processing of Personal Data is necessary for the performance of a task carried out in the exercise of official authority vested in Identità.

03 Recipients of personal data

Data will be accessed by Identità employees in charge of processing the POA.

It may also be transferred to other departments within Identità in order to facilitate the delivery of the service requested by submitting this POA. Data will also be transferred to the Police Immigration Office and the National Statistics Office.

This will be done in line with data protection legislation, and arrangements are in place in order to guarantee the security and lawfulness of these transfers. Under certain conditions, Identità may disclose your information to other third parties, (such as other Government entities or law enforcement authorities) if it is necessary and proportionate for lawful, specific purposes.

Data will not be transferred to third countries or international organisations.

04 Storage period

Data will be retained for 10 years.

05 Your rights

You can contact the Data Protection Officer in order to exercise your right to access, rectify and, as the case may be, erase the Data, in compliance with applicable laws.

You also have the right to object to the processing of Data at any time, on grounds relating to your particular situation.

If you feel that Identità has infringed your data protection rights, you may submit a complaint to the supervisory authority of the Member State of your habitual residence or place of work, or, alternatively, to the supervisory authority of the Member State where the alleged infringement has taken place.

Politika tal-Privatezza - Prokura

Bis-sottomissjoni tal-Prokura flimkien ma' kwalunkwe dokumenti neċċesarji ohra annessi magħha (il-koll "Prokura"), inti qed tiprovd i l-Aġenzija Identità b'informazzjoni personali, u għalhekk issir suġġett tad-data.

L-ghan ta' din il-politika dwar il-privatezza huwa sabiex inkunu konformi mal-obblighi ġusti u trasparenti taht ir-regolamenti ġeneralji dwar il-protezzjoni tad-data, u biex ninfurmaww dwar min se jkun qed jipproċċessa l-informazzjoni tiegħek, għal liema għan, għal kemm żmien se tinżamm, ma' min se tkun qed tinqasam u dwar id-drittijiet tiegħi bħala suġġett għad-data taht ir-regolamenti ġeneralji dwar il-protezzjoni tad-data.

Inti tista' tissottommetti informazzjoni personali ta' individwi ohra permezz ta' din il-Prokura. Identità stabbilit li, f'tali cirkostanzi, ikun impossibbli li tinforma lil dawn l-individwi u tali eżerċizzu jirrikiedi sforz kbar. Identità se tappilka mizuri adegwati sabiex tiprottegi d-drittijiet, il-libertajiet u l-interessi leġġitimi ta' dawn l-individwi.

01 Uffiċjal ghall-Kontroll tad-Data u Protezzjoni tad-Data

L-Aġenzija Identità hija l-kontrollur tad-data, li jfisser li hija l-entità li tistabbilixxi l-ġħannejiet u l-meżzi li bihom tiġibor u tiproċċessa l-informazzjoni tiegħek b'rabitba ma' din il-Prokura. Identità hija aġenċija tal-Gvern ta' Malta li toffri servizi b'rabitba ma' Karti tal-Identità, Passaporti, Visi, Espatrijati u Reġistru Pubbliku. L-Uffiċjal tal-Protezzjoni tad-Data ta' Identità huwa responsabbi li jindirizza kwalunkwe mistoqsja b'rabitba ma' dawn ir-regolamenti u b'mod in-ġenerali dwar attivitajiet ta' proċċassar ta' data li jsir minn Identità. 02 Għanġiġiet u bażi legali

L-ipproċċassar ta' data personali huwa neċċesarju sabiex jiġi mwettaq kompitu uffiċċiali ta' Identità fil-qadi ta' dmirrijietha.

03 Min se jaċċessa l-informazzjoni personali

L-impiegati ta' Identità se jkollhom aċċess għall-informazzjoni personali tiegħek sabiex jipproċċessaw din il-Prokura.

Din l-informazzjoni tista' tkun trasferita lil dipartimenti fi hdan Identità sabiex tiffaċċila t-twettiq tas-servizz mitlub permezz tas-sottomissjoni ta' din il-Prokura.

Id-data se tkun trasferita wkoll lill-Korp tal-Pulizija u lill-Uffiċju tal-İstatistika Nazzjonali.

Dan se jsir fuq il-linji għwida tal-Liġi tal-Protezzjoni tad-Data, filwaqt li hemm bosta arranġamenti sabiex jiggħarantixxu s-sigurtà ta' dawn it-trasferimenti, u biex kollox isir skont il-lijgi.
