02 Purposes and legal basis

The purpose of processing personal data collected within this form is for the landlord to confirm that a third country national previously registered on the landlord's address, has been deregistered and is no longer residing at the aforementioned address.

The legal basis for processing the Data are the performance of a task carried out in the public interest by Identità and in compliance with the legal obligation deriving from SL 460.17, to which Identità is subject. We take pride in keeping your data secure and will take appropriate technical and organisational measures to protect your data against unauthorised or unlawful processing, including against accidental loss, destruction, storage or access. Your personal data will be stored in paper files and/or electronically on our technology systems.

03 Recipients of personal data

Data will be accessed by Identità employees in charge of processing the Form.

It may also be transferred to other departments within Identità in order to facilitate the delivery of the service requested by submitting this Form.

This will be done in line with data protection legislation, and arrangements are in place in order to guarantee the security and lawfulness of these transfers.

Under certain conditions, Identità may disclose your information to other third parties, (such as other Government entities or law enforcement authorities) if it is necessary and proportionate for lawful, specific purposes. Data will not be transferred to third countries or international organizations.

04 Storage period

Data will be retained for 10 years from the moment that the file is considered as dormant.

05 Your rights

You can contact the Data Protection Officer in order to exercise your right to access, rectify and, as the case may be, erase the Data, in compliance with applicable laws.

You also have the right to object to the processing of Data at any time, on grounds relating to your particular situation. If you feel that Identità has infringed your data protection rights, you may submit a complaint to the supervisory authority of the Member State of your habitual residence or place of work, or, alternatively, to the supervisory authority of the Member State where the alleged infringement has taken place.

In the event of complaints, any data or documentation provided by the complainant to Identità will be treated with the utmost confidentiality and will not be shared with any third party. Data may only be shared with other government authorities for verification and investigation purposes, if required and authorised by law. The complainant will receive an update on the matter without the disclosure of any personal data given that disclosure of personal data is prohibited under the General Data Protection Regulations. This information may be forwarded to the Police or any other relevant authority as necessary, for any action as may be required.
