**DECLARATION BY APPLICANTS OF WORKING HOLIDAY VISA**

The Memorandum of Understanding signed between the Government of Malta and the Government of Andorra allows for nationals of Andorra to obtain a Working Holiday Visa for a maximum tenure of 365 days. The issuance of such visa is dependent on a due diligence process taking into consideration public policy, public security, and public health.

The Memorandum of understanding is based on the applicant making a rightful and truthful declaration and submitting authentic documentation. Any failure from applicant in this regard can result in the refusal or retraction of such visa.

Note: The below declaration must be signed by all applicants.

I, the undersigned, declare that:

1. I am in possession of at least the equivalent of the minimum wage in Malta for my maintenance during the first three months of accommodation.
2. I understand that any registration or licensing that is required before I can begin employment in Malta will be my responsibility.
3. Any employment is incidental to my holiday in Malta and the purpose of working is to supplement my holiday funds.
4. I am aware that I must inform Identità in writing on [workingholiday.identita@gov.mt](mailto:workingholiday.identita@gov.mt) as soon as I become aware of a change in circumstances or information that has already been provided during the application process for this visa. Such notification must reach Identità in writing within no later than seven days of the applicant becoming aware of it.
5. I will depart from Malta at the end of my authorised stay.

I agree to abide by these conditions.
