CHECKLIST FOR CHANGE OF ADDRESS, LOST, STOLEN OR DAMAGED CARD

NON-EU

CHANGE OF ADDRESS

- Changes to Application Form;
- Existing Residence Card (to be retained by Identità) and a copy of the residence card (front & back);
- Valid passport and a copy of the biometric page of the passport;
- Valid Lease Agreement or Purchasing agreement;
- Housing Authority Approval email (not required if you own the property in Malta);
- Lease Agreement Attestation Form (not required if you own the property in Malta);
- Long term residence holders and family member residence permit holders: Architect Attestation (not required if you own the property in Malta);
- Family Members: Interim Receipt or Copy of Sponsor's residence permit updated to the new address (front & back);
- Exempt: Copy of the Maltese National's sponsor ID updated to the new address.

Application fee - Non-EU Nationals - €50

Exempt & Brexit - NIL

LOST, STOLEN OR DAMAGED CARD

- Lost or Stolen Cards - Valid local Police report issued within 3 days of being lost/stolen
- Valid passport and a copy of the biometric page of the passport
- Damaged Card - Present Damaged Card

Application fee - Non-EU Nationals (and their family members) - €50

Brexit - €22

OTHER CHANGES

- Applicant may be requested to provide supporting documentation by the Agency, depending on and as applicable to the change being requested.

CHANGE OF ADDRESS

- Changes to Application Form;
- Existing Residence Card (to be retained by Identità);
- Proof of address: Such as utility bills, bank statements, contract of lease or contract of purchase of property with the details of the applicant. In case of applicants who cannot provide proof of address, kindly provide CEA Form D – Address Declaration;
- Application fee - EU Nationals (and their family members) - NIL;
- Original and copy of a valid travelling document (Passport / Foreign ID);
- Exempt: Copy of the Maltese National's sponsor ID updated to the new address.

LOST, STOLEN OR DAMAGED CARD

- Lost or Stolen Cards - Valid local Police report issued within 3 days of being lost/stolen;
- Damaged Card - Present Damaged Card.

Application fee - EU Nationals (and their family members) - Lost Card €22

EU Nationals (and their family members) - Damaged Card €16.50

OTHER CHANGES

- Applicant may be requested to provide supporting documentation by the Agency; depending on and as applicable to the change being requested.
