**DOCUMENTATION REQUIRED FOR FAMILY REUNIFICATION VISA  
(FOR VISAS OF MORE THAN 90 DAYS)**

---

- 01 Fully filled in Visa Application form signed by the applicant;
- 02 Passport. Must have a minimum validity of 8 months;
- 03 1 Passport photo according to ICAO Standards;
- 04 Family reunification certificate issued by the Expatriates unit, Identità;
- 05 Flight ticket details. Full flight itinerary must be provided, indicating applicant's name, date of flight, and all stops - preferably transiting outside the Schengen area;
- 06 Invitation letter by sponsor, confirming that he will be inviting family member/s to stay here in Malta;
- 07 Proof of Accommodation:
  - Declaration of proof - This is to be provided in those cases where the host will be providing the applicant with free accommodation. Declaration of proof must be signed and stamped by a local lawyer or notary. Together with this, a copy of the host's ID Card, and proof of residence, such as a utility bill, must be provided. If the applicant will be accommodated at a secondary address this must be stated;
  - Lease Agreement – This must be signed by both parties and stipulate the duration, home address, and name of applicant, and amount of rent, must also include the names of persons living with the sponsor;
- 08 Medical and Travel Insurance:
  - Must be valid for the Schengen area;
  - Must have a minimum medical coverage of €30,000;
  - Must include name, surname, and passport number.
  - Assurance that the coverage will be valid for non-applicable residents.
  - Insurance should cover applicant from point of entry, and last a minimum of 180 days.
- 09 Full Passport Copy;

**10** Original marriage certificate legalised in the country of origin and translated in English by an official translator;

In case of minors travelling and accompanying both parents the following documents are also required:

- 01 Copy of minor's passport;
- 02 Copy of both parents' passport;
- 03 Original birth certificate legalized in the country of origin and translated in English by an official translator;

In case of minors travelling and accompanying one parent, the following documents are also required:

- 01 Copy of minor's passport;
- 02 Copy of both parents' passport;
- 03 Original birth certificate legalized in the country of origin and translated in English by an official translator;

**13** Host's Maltese residence card & passport;

**14** Fees to be settled by credit/visa card:

**Standard Visa Application fees:**

- i.** 0-6 years: Free
- ii.** 6-12 years: €50
- iii.** 12 years onwards: €150

**Extended Visa Application fees:**

- i.** 0-6 years: Free
- ii.** 6-12 years: €50
- iii.** 12 years onwards: €250
